TERMS & CONDITIONS

- Payment:** The completed registration form together with the course fee payment (50%) must be submitted to CSC by 31 January 2019 prior to the commencement of Term 1 (February 2019). The remaining 50% is to be paid by 15 May 2019 before the commencement of Term 2 (June 2019). Payment can be made via cheque, credit card, nets or cash at the CSC Front Office. All trainees are advised to settle all payments by the stipulated date. For Non-Members, please also submit a photocopy of the trainee's birth certificate or NRIC upon enrolment.
- Withdrawal:** Please note that there will be no refund or proration of course fee in any circumstances. All trainees are required to complete the one-year programme once enrolled.

3. **Class Cancellation:** There will be no training on Public Holidays and eve of Public Holidays unless otherwise stated. CSC reserves the right to cancel any training session at any time. CSC shall use its best endeavours to inform trainees of any such cancellation in advance but shall not be liable if no advance notice is given. In the event of a cancellation, CSC will schedule make-up lessons in consultation with the coaches and trainees. There shall be no refund or proration of course fee arising from any cancellation.
4. **Make-up Lessons:** Trainees who are unable to attend training due to illness or injury are required to produce a medical certificate for scheduling of make-up lessons. Advance notice of at least a month is required should the trainee be missing lessons due to overseas travel. Make-up lessons for last minute absence will be reviewed on a case-by-case basis. All make-up lessons have to be completed within the month. There shall be no refund or proration of course fee arising from any absence.
5. **Bowling Lane Fee:** For each training session, two (2) trainees will train at each lane. Trainees will enjoy a preferential rate which is payable directly to 12 Lanes Bowl after every training.
6. **Rules & Regulations (For Non-Members):** Non-Member trainees must present their identity card to the security for access to the Club for their training. CSC reserves the right to require any trainee to produce his or her Identity Card prior to permitting that trainee from taking part in any Academy activity or training. CSC reserves the right to refuse any trainee access to any Academy activity or training where that trainee is not wearing the Academy T-shirt or improperly attired. No outside food may be brought into the Club. All trainees and caregivers shall comply with the terms and conditions governing the use of CSC's facilities at all times. CSC and their appointed staff and officials reserve the right not to admit any person who has been previously ejected from its premises. CSC and their appointed staff and officials reserve the right to eject any trainee or caregiver who behaves in a disorderly manner or who is nuisance or a threat in its premises. CSC reserves the right to impose a reinstatement fee for any damage caused to the Club or its property by any trainee or caregiver. CSC shall determine the cost of the damage.

Non-Member trainees and their caregiver can only access the Club during their training period and are required to leave the Club immediately after training. Only one (1) caregiver or parent as registered above may accompany a trainee below 12 years old at any one time. Any facilities other than 12 Lanes Bowling Alley and rest room is out of bounds to the trainees and their caregiver. Trainees shall be withdrawn from the Academy if they or their caregiver breach any of the above terms and conditions.
7. **Photography/Videography:** Photographs and videos may be taken during Academy activities and trainings for use in the CSC's archival and publicity materials.
