- 1. Must be studying in a Junior College/Polytechnic (Non-Private) or serving National Service.
- 2. Must have been training with the Club for a continuous period of not less than 3 years prior to date of application.
- 3. Must have at least participated and **won a medal(top 3 ranking) in any Inter-Club** meets during his/her swimming stint with the Club for the past 3 years.
- 4. Must have regular training attendance in the past 3 years (**minimum of 5 sessions a week**).

Terms and Conditions

General (Apply to Category 1 and 2)

- 1. Must participate in all Inter-Club competitions whenever requested by the Club. Upon refusal to participate when requested by the Club, the Club reserves the right to bill the difference in the swimming fees retrospective to the month the concession fee was effected.
- 2. The concession fee will be effective from the month it has been approved. There will strictly no pro-rated or retrospect billing.
- 3. The application is subject to the approval of the Swimming Sub-Committee.
- 4. The Swimming Sub-Committee reserves the right to reject any application without assigning any reasons.

Category 2

- 1. Must attend at least minimum of 8 sessions per month.
- 2. The Concession fee application is on a yearly basis. The last month of the concession fee will be December and normal training fee will apply if application form and supporting documents are not received by 15 December of the same year for application for the next year.
