RULES AND REGULATIONS

I undertake to observe the following rules now in force, subject to any amendments, from time to time.

1. My child/ward have to represent Chinese Swimming Club in all meets as required by the Club.
2. My child/ward shall not represent or train in any other clubs in swimming.
3. I agree to pay the training fees, even if I do not come for regular training.
4. Fees (wef Aug 2008) \$74.90 (Inclusive of 7% GST) monthly to be charged to members' account.
5. Refund Training Fees for all classes are **NON-REFUNDABLE** under any circumstances.
(Pro-rated refunds will not be entertained.)
6. Termination Members must give **two weeks' notice** before the start of the next month by returning the completed withdrawal form.

The Swimming Sub-committee may not recommend any swimmers for special concession rate in the conversion fees, from junior to ordinary member on the following grounds:

- A. If he / her training fees is in arrears.
- B. If he / she competes against Chinese Swimming Club.
- C. If he / she refuses to represent the club without valid reasons.

INDEMNITY
