2. The Dunlop XX, double yellow dot squash balls will be the official ball for the tournament.
3. The tournament will be played based on the 15-Point System.
4. All matches will be played to the best-of-1 game.
5. All players will be divided into 2 teams and each team will be played on a Round-Robin format.
6. All players will be required to assist in the refereeing and marking of matches when being called upon by the tournament organiser.
7. Prizes will only be given out at the end of the tournament during the Prize Presentation Dinner.
8. Players are advised to be at the Squash Court at least 15 minutes before the time of their scheduled match.
9. A walk over will be declared to the player that is present, if his/her opponent fails to be present 10 minutes after the time of their scheduled match.
