RULES & REGULATIONS

- I wish to be registered with the Club's Swimming Team and I undertake to observe the following rules now in force, subject to any amendments, from time to time:
1. I have to represent Chinese Swimming Club in all meets as required by the Club.
 2. I shall not represent any other clubs in swimming or train in any other clubs.
 3. I agree to pay the monthly training fees of *S\$107.00 and that my absence from lessons does not indicate my withdrawal from the programme unless the Official Withdrawal Form is submitted in accordance with the Withdrawal Procedures below.
 4. A registration fee of *S\$32.10 will be charged to my account. An administration fee of *278.20 is applicable for Squads A to D swimmers who withdraw from the Programme and wish to re-join. Re-join is only allowed for swimmers who left the programme for more than 6 months.
 5. I understand that Registration / Re-registration Fees and Swimming Fees for all classes are **NON-REFUNDABLE** under any circumstances (*pro-rated refunds will not be entertained*).
 6. The Club reserves the sole right to amend any Terms & Conditions of the operations of the swimming programmes without prior notice.

* Price includes 7%GST.

The Swimming Sub-Committee may not recommend a swimmer for special concession rate in the conversion fees, from Junior to Ordinary member if:

- A. the swimmer's fees is in arrears.
- B. the swimmer competes or has competed against the Club.
- C. the swimmer refuses to represent the Club without valid reasons.

WITHDRAWAL PROCEDURES

1. Withdrawal must be indicated in advance in the prescribed Official Withdrawal Form.
2. Withdrawal Forms received by the Club **on or before the 15th day of the month** will be processed within the month; the training fee for the current month will be debited accordingly and will cease in the following month.
3. Withdrawal Forms received by the Club **after the 15th day of the month** will be processed in the following month; the training fee for the current and following month will be debited accordingly and will only cease thereafter.
4. Backdated Withdrawal Form will not be entertained.

INDEMNITY

In this declaration, I hereby agree that I will not hold Chinese Swimming Club, their appointed staff or officials responsible in any way for any mishaps, injuries or loss of life or loss of damage to any property howsoever arising out of or in the course or in connection with the above activity; and I shall indemnify Chinese Swimming Club and their appointed staff and officials from any actions, proceedings, liabilities, claims, damages, cost and expenses which may be brought by or asserted against them by any person in any connection with the same.
