  - Participant (s) taking Private Lesson **MUST NOT** swim against the Club in any Competitions.
  - Principle Members and Term Members shall be responsible for their spouses and children. Any breach of provision in the Rules & Regulations and any false information provided by a spouse or child of the Principle Member or Term Member shall be deemed to be the misconduct of the Principle Member or Term Member.
  - Participant (s) found violating the Rules & Regulations will have his/her private swimming lessons terminated with immediate effect.
  - The Club reserves the sole right to amend any Terms & Conditions of the operations of the swimming programmes without prior notice.
