



# APPLICATION FOR SPOUSE MEMBERSHIP

The application form must be duly completed, together with the relevant documents and payment attached before the Club could process the application.

## Spouse Member – New Application / Replacement

- a) Photocopy of marriage certificate
- b) Photocopy of spouse's identity card
- c) 2 recent passport-sized colour photographs of applicant
- d) Cheque payment for entrance fee
  - Subject to the date the Principal Member joined the Club
  - Not applicable for replacement of spouse's membership

- e) All married persons who become Principal Members, Nominees or Term Members on or after **28 April 2013** are required to register their spouse as Spouse Members. All single persons who become Principal Members or Term Members on or after **28 April 2013**, and are subsequently married are also required to register their spouse as Spouse Members.
- f) If the Spouse of a Principal, Nominee or Term Member is not registered with the Club in accordance with Article 5.1(f) of the Club's Constitution, that Member will be required to register his/her spouse as a Spouse Member and pay up to 3 times of all outstanding subscription fees due from the date the spouse should have been registered with the Club. Failure to do either may result in disciplinary proceedings against the member.
- g) With effect from **28 April 2013**, as long as the Principal, Nominee or Term Membership is not terminated, that individual shall not be permitted to de-register his/her spouse, except in the event of divorce or death.
- h) For replacement of spouse's membership, the Principal Member has to withdraw the membership of the previous registered spouse. Relevant documents must be submitted and the previous spouse's membership card to be returned to the Club. (Note: A penalty charge of \$10.70 will be imposed if spouse membership card is not returned)
- i) If any person is de-registered as a Spouse Member or Spouse Term Member before **28 April 2013**, then an administrative fee of \$107 (including GST) is payable for a fresh application to be Spouse Member or Spouse Term Member.

## Life Member

- a) For Life Member without a credit account, cheque payment of \$100 being credit deposit for your spouse credit account is required.

## Child under 12 years old

- a) Any child, of a Principal Member or of a Nominee, under the age of 12 years must be registered with the Club as a child dependent and such a child may use the Club's facilities without payment of a guest fee.
- b) A copy of your child's birth certificate is required.

## Child 12 years old to 21 years old

- a) Any child, of a Principal Member or of a Nominee, between 12 years up to just before 21 years of age must be registered as a Junior or Child Member failing which such child may only use the Club's facilities as a guest and the Bye-laws on guests shall apply to such child. Such child may be registered as a Junior Member only if he satisfies Article 5.1(g) of the Constitution.

## Billing of Subscription Fee

Application received by the Club on or before the 15th day of the month will be processed and subscription fee billed for the same month.

Application received by the Club after the 15th day of the month will be processed and subscription fee billed the following month.
