## **TERMS AND CONDITIONS**

1. **Payment:** For Members, completed registration form must be submitted to CSC by the 25th of the preceding month prior to the commencement of training. Enrolment fee & Training fee will be debited from your account with CSC. Training fee for subsequent months will be debited from your account with CSC in advance of the training month.

For Non-Members, completed registration form, together with a passport size photo, photocopy of BC/NRIC & payment (enrolment fee, training fee & deposit) must be submitted to CSC by the 25th of the preceding month prior to the commencement of training. Training fee payment for subsequent months must be submitted by 15th of the month preceding the training month via cheque, credit card, nets or cash at the CSC Front Office. **Non-CSC member Trainees who fail to settle payment by the stipulated date shall be deemed to have withdrawn from the Academy.**

2. **Withdrawal:** A duly completed official withdrawal form must reach CSC on or before the 15th of the current month for cessation of training to be effective the following month. Training will only cease the month following the next month if CSC receives the withdrawal form after the 15th of the month.
3. **Class Cancellation:** Training will continue as scheduled on Public Holidays except the first 7 days of the Chinese New Year and unless otherwise stated. CSC and / or the Academy reserves the right to cancel any training session at any time. CSC and / or the Academy shall use its best endeavours to inform trainees of any such cancellation in advance but shall not be liable if no advance notice is given. Where CSC and / or the Academy have cancelled a training session, Trainees may replace that training sessions on the next available date falling within fourteen (14) days of the date of the cancelled training session subject to availability.

Trainees who are unable to attend due to illness or injury are required to produce medical certificate for scheduling of make-up lessons. Advance notice of at least a month is required should the trainee be missing lessons due to overseas travel. Make-up lessons for last minute absence will be reviewed by a case-by-case basis. All make-up lessons have to be completed within the month. There shall be no refund or pro-ration of Training Fees arising from any cancellation or absence.

4. **Rules & Regulations (Non-CSC Members):** Non-CSC Member Trainees must present their identity card to the security for access to the Club for their training. CSC and / or the Academy reserve the right to require any Trainee to produce his or her Identity Card prior to permitting that Trainee from taking part in any Academy activity or training. CSC and / or the Academy reserves the right to refuse any Trainee access to any training or other Academy programme where that Trainee is not wearing Babolat T-shirt or improperly attired. No outside food may be brought into the Club. All Trainees and caregivers shall comply with the terms and conditions governing the use of CSC's facilities at all times. CSC and their appointed staff and officials reserve the right not to admit any person who has been previously ejected from its premises. CSC and their appointed staff and officials reserve the right to eject any Trainee or caregiver who behaves in a disorderly manner or who is nuisance or a threat in its premises. CSC reserves the right to impose a reinstatement fee for any damage caused to the Club or its property by any Trainee. CSC shall determine the cost of the damage.

Non- CSC Member Trainees and their caregiver can only access the Club during their training period and are required to leave the Club immediately after training. Only one (1) caregiver or parent as registered above may accompany a Trainee below 12 years old at any one time. Any facilities other than the Badminton courts and rest room is out of bounds to the Trainees and their caregiver. CSC/Babolat shall have the right to forfeit and/or set off the deposit against any outstanding Training fees or other fees and any expenses incurred or to be incurred by CSC and/or Babolat to rectify any damage caused by the non-CSC member Trainee, or in the event that the non-CSC member Trainee is expelled or does not return the Academy Card upon termination of enrolment for whatever reasons. Trainees shall be withdrawn from the Academy if they or their caregiver breach any of the above terms and conditions. Their deposit shall be forfeited and the Trainee shall be barred from joining any other Babolat Badminton Academy.

5. **Photography/Videography:** Photographs and videos may be taken for use in the CSC's archival and publicity material.
