



CHILD/CHILD TERM MEMBERSHIP APPLICATION

A note to Parent

1. Please submit the following when applying for Child/Child Term membership:
 - a) 2 recent passport-sized colour photographs
 - b) a photocopy of his/her Birth Certificate
 - c) a photocopy of his/her Identity Card/Passport
 - d) cheque payment of \$428.00 (GST inclusive) per child, being registration fee.
2.
 - a) With effect from **28 April 2013**, all children of Principal Members shall be registered with the Club as Child Members within six (6) months of each child attaining the age of twelve (12) years.
 - b) If a child of a Principal, Nominee or Term Member is not registered with the Club in accordance with Article 5.1(h), that Member will be required to register his/her child as a Child Member and pay up to 3 times of all outstanding subscription fees due from the date the child should have been registered with the Club. Failure to do either may result in disciplinary proceedings against the member.
 - c) As long as the Principal, Nominee or Term Membership is not terminated, that individual shall not be permitted to de-register his/her Child/Child Term Memberships respectively, except in the event of death or where the member loses custody of the child.
3. Subscription fee for Child/Child Term Membership shall be billed in advance to your account on an annual basis.

Note:

- i) Application received by the Club **on or before the 15th day of the month** will be processed and subscription fee billed for the same month.
 - ii) Application received by the Club **after the 15th day of the month** will be processed and subscription fee billed the following month.
4. If you wish to authorise your child/children to sign bills incurred at the Club, please complete and submit the attached "Application for Credit Account" form and the "Specimen Signature" form.
5. Please be informed of the following:-
 - a) Article 6.2(a) of the Club Constitution states that Principal Members and Term Members shall be responsible for the conduct and debts of their spouses and children. Any misconduct or breach of a provision in the Constitution or Bye-Laws by a spouse or child of a Principal Member or Term Member shall be deemed to be the misconduct of that Principal Member or Term Member.
 - b) As stated in the Bye-Laws, Sports Members, Junior Members, Child Members, Junior Term Members, Child Term Members and Social Members are not permitted to bring guests.
6. If any person is de-registered as a Child/Child Term Member, an administrative fee of \$107 (GST inclusive) is payable for a fresh application to be a Child/Child Term Member. This clause is not applicable after 28 April 2013.
