TERMS AND CONDITIONS

- Payment:** For Members, completed registration form must be submitted to CSC by the 25th of the preceding month prior to the commencement of training. Enrolment fee & Training fee will be debited from your account with CSC. Training fee for subsequent months will be debited from your account with CSC in advance of the training month.

For Non-Members, completed registration form and payment (training fee & deposit) must be submitted to CSC by the 25th of the preceding month prior to the commencement of training. Training fee payment for subsequent months must be submitted by 15th of the month preceding the training month via cheque, credit card, nets or cash at the CSC Front Office.

Non-CSC member Trainees who fail to settle payment by the stipulated date shall be deemed to have withdrawn from the Academy.

- Withdrawal:** A duly completed official withdrawal form must reach CSC on or before the 15th of the current month for cessation of training to be effective the following month. Training will only cease the month following the next month if CSC receives the withdrawal form after the 15th of the month.

3. **Class Cancellation:** Training will continue as scheduled on Public Holidays unless otherwise stated. CSC and/or LJE Sports reserve the right to cancel any training session at any time. CSC and/or LJE Sports shall use its best endeavours to inform trainees of any such cancellation in advance but shall not be liable if no advance notice is given. In event of wet weather, Trainees will be informed via SMS on cancellation at least 30 minutes to start of lesson. Where CSC and/or LJE Sports have cancelled a training session, a refund will be processed for that session. Trainees who are unable to attend due to illness or injury are required to produce medical certificate for processing of refund. There shall be no refund or pro-ration of Training Fees arising from any absence for non-medical related reasons.
4. **Rules & Regulations (Non-CSC Members):** CSC and/or LJE Sports reserve the right to require any Trainee to produce his or her Identity Card prior to permit that Trainee from taking part in any Academy activity or training. No outside food may be brought into the Club. All Trainees and caregivers shall comply with the terms and conditions governing the use of CSC's facilities at all times. CSC and their appointed staff and officials reserve the right not to admit any person who has been previously ejected from its premises. CSC and their appointed staff and officials reserve the right to eject any Trainee or caregiver who behaves in a disorderly manner or who is nuisance or a threat in its premises. CSC reserves the right to impose a reinstatement fee for any damage caused to the Club or its property by any Trainee. CSC shall determine the cost of the damage.
- Non- CSC Member Trainees and their caregiver can only access the Club during their training period and are required to leave the Club immediately after training. Only one (1) caregiver or parent as registered above may accompany a Trainee below 12 years old at any one time. Any facilities other than the Basketball Court and restrooms are out of bounds to the Trainees and their caregiver. CSC/LJE Sports shall have the right to forfeit and/or set off the deposit against any outstanding Training fees or other fees and any expenses incurred or to be incurred by CSC and/or LJE Sports to rectify any damage caused by the non-CSC member Trainee. Trainees shall be withdrawn from the Academy if they or their caregiver breach any of the above terms and conditions. Their deposit shall be forfeited and the Trainee shall be barred from joining any other training at CSC.
5. **Photography/Videography:** Photographs and videos may be taken for use in the CSC's archival and publicity material.
