Maximum 12 swimmers per session allocated on a first-come-first-served basis. Minimum class size of 6 swimmers to start. Swimmers should be 7 years old (as of current year) and be at a **minimum height of 120cm**.

Note: Swimmers are required to bring personal nose clip, goggles and yoga mat. Recommended attire for participants will be black swimwear and white swim cap.

RULES & REGULATIONS

I wish to be registered with the Club's Swimming Guest and I agree to abide by the following rules now in force, subject to any amendments, from time to time:

- I agree to pay the abovementioned term training fees (**12 weeks per term, 1 lesson per week**) and that my absence from lessons does not indicate my withdrawal from the Programme. The Official Withdrawal Form must be submitted to the Sports Desk located at Level 2 of the Sports Complex. Please refer the Withdrawal Procedures.
- I shall pay a one-time registration fee (applicable to new registrant only) of **\$30.00 (excl. 7% GST)**. Registration fees are non-refundable.
- I agree to pay a one-month refundable deposit of **\$120.00 (excl. 7% GST)** prior to the commencement of my lesson.
- All fees stated above are **NOT inclusive of 7% GST**.
- I understand that training fees, registration fees, deposit and/or any miscellaneous payment will have to be paid prior to commencement of the lesson.
- There is no pro-rating of fees under any circumstances and no refunds for any mid-term withdrawals.
- Registration is for a period of up to 2 terms (6 months) in the non-member scheme. Parents will then be required to take up a full CSC Membership to continue in the Programme.**
- I understand that Parking Fee will not be waived off as it is a privilege for CSC members.
- I will only be allowed to use facilities including the swimming pools, changing rooms, toilets and patronage of our F&B outlet.
- Changes to the registered class timing after commencement of the first lesson will NOT be accepted.
- Swimmers shall be punctual for class as there will be no extension of time for latecomers.
- There will be strictly no make-up class for non-attendance on the part of the swimmer. Those with medical certificates (MC) will be reviewed on a case-to-case basis.
- There will be **No Class on Public Holidays** unless stated otherwise.
- At all times, the Club reserves the sole right to amend any of these Terms & Conditions without prior notice.

BAD WEATHER / HAZE GUIDELINES

1. Bad weather is defined as having lightning or heavy rain within close proximity and the pool is closed by the pool management and/or lifeguard and/or CSC staff.
2. Haze advisory
 - a. PSI 150 & below – lessons as per normal
 - b. PSI 150 & above – lessons will be cancelled
 - c. The Club will check the PSI level an hour before the commencement of lessons and update the status on Swim CSC Facebook page.

WITHDRAWAL PROCEDURES

1. Withdrawal must be indicated in advance in the prescribed Official Withdrawal Form.
2. Withdrawal Forms for the next term must be submitted 14 days prior to the start of the new term.
3. Postdated Withdrawal Forms or verbal requests over the phone/ in person will not be accepted.

INDEMNITY
