- 1. Coach: All lessons are subject to the availability of the trainee's preferred coach.
- 2. Court booking: The CSC member will be responsible for booking the tennis court for the lesson.
- 3. **Cancellation:** Notice of any cancellations must be provided no later than 12 pm on the day prior to the day of the lesson. Otherwise, the full lesson fee will be charged to the CSC member's membership account.
- 4. **Contingency:** If it rains or if there is thunder and/or lightning within 30 minutes into the lesson, half of the hourly fee will be charged. If it rains or if there is thunder and/or lightning at any point in time after 30 minutes into the lesson, the remainder of the lesson will be charged in blocks of 15 minutes.

- 5. Payment: The coaching fees shall be charged to the CSC member's membership account on a monthly basis.
