4. Withdrawal received by the Club on or before the 15th of the month will be processed within the month. Charges for the activity will cease in the following month.
5. Withdrawal received by the Club after the 15th of the month will be processed in the following month. Charges for the activity will be debited accordingly in the following month and ceased thereafter.
6. Only the official withdrawal form from the Sports Desk / Front Office is acceptable.
7. Please note that photographs and videos may be taken during trainings / tournaments for use in our archival and publicity material.
