## RULES & REGULATIONS

### 1. ELIGIBILITY

- a) All members who hold valid USGA handicap certificates are eligible to apply for membership of the CSC Golf Section subject to the approval of the Sub-Committee.
- b) Members must join the Golf Section for a continuous six months to enjoy the privilege of concession golfing package. Members who withdraw before six months must still pay for the section fees of the remaining month.

### 2. CHARGES

I hereby authorise the Club to debit \$10.80 (inclusive of 8% GST) per month to my account even if I do not participate regularly in any Golf Section activity.

### 3. WITHDRAWAL

- a) Withdrawal notice received by the Club on or before the 15th of the month will be processed within the month. Charges for the activity will cease in the following month.
- b) Withdrawal notice received by the Club after the 15th day of the month will be processed in the following month. Charges for the activity will be debited accordingly in the following month and cease thereafter.
- c) Only the **OFFICIAL** Withdrawal Form obtainable from Sports Desk is acceptable. Verbal withdrawal will not be entertained.

### 4. INDEMNITY

In this declaration, I hereby agree that I will not hold Chinese Swimming Club, their appointed staff or officials responsible in any way for any mishaps, injuries or loss of life or for loss of damage to any property howsoever arising out of or in the course of or in connection with the above activities; and I shall indemnify Chinese Swimming Club and their appointed staff and officials from and against any actions, proceedings, liabilities, claims, damages, cost and expenses which may be brought by or asserted against them by any person in connection with the same.
