| | Baby 1 | 3:30pm* | 12 to 24 months | The child is introduced to the aquatic environment through games and songs. Parents are taught how to handle their children in the water. |
| | Baby 2 | 4:10pm* | 24 to 36 months | The child is more aware of his/ her surroundings. Kicking and movements are incorporated into the swimming program. Board kicking, armbands and floatation aids are introduced to enhance the child's enthusiasm in the water. |
| | Baby 3 | 4:45pm* | 36 to 48 months | More advanced techniques like submersion; different ways to do submersion as well as free fall swimming are introduced. The child will be able to feel self-propulsion with regular swimming. |

Note: One Parent must accompany the child during class (domestic helpers are not allowed).

RULES & REGULATIONS

I undertake to observe the following rules now in force, subject to any amendments, from time to time:

1. **There shall be strictly no refund or pro-rate of training fee.**

4. Fees: 1 time payment for 8 lessons to be charged to members' account.
5. Class Size: 1 coach to 8 babies (maximum) (Note: Minimum 4 babies to start). The Club reserves the right to cancel or re-schedule the class should there be not insufficient students.
6. Should the coach be on MC, another coach shall be activated, otherwise, lesson(s) shall be cancelled, and replacement class(es) will be made known.
7. The Club reserves the sole right to amend any Terms & Conditions of the operations of the swimming programmes without prior notice.
