### **OVERVIEW – Chinese Swimming Club (CSC)**

Founded in 1905, The Chinese Swimming Club (“CSC”) is one of the oldest private clubs located in the idyllic east of Singapore. CSC has a longstanding tradition of sporting excellence, having produced some of the nation's top swimmers and athletes.

Beyond swimming, CSC is a vibrant social and sporting hub that offers an extensive range of programs and facilities to its members. Badminton is the second most popular sport at CSC and is supported by a dedicated, purpose-built badminton hall with eight courts.

In October 2023, CSC was granted a 30-year lease extension for its sports complex by the Singapore Land Authority, a testament to the club’s strong commitment to the community and its support of sporting excellence in collaboration with the various National Sporting Associations (NSAs).

#### **Chinese Swimming Club Badminton Academy (CSCBA)**

For the past few years, CSC has had an operator running its badminton academy, developing and nurturing young and keen badminton enthusiasts from the club’s membership base as well as non-members from around the area. In addition, CSC also holds and organises the largest and oldest National Age Group competition in Singapore annually.

In line with the lease extension, CSC is looking to redefine and elevate the long-term ambitions of its Badminton Academy, by focusing on developing top badminton players to represent the club and country and in the process improve the organisation of its annual Age Group Competition to become Singapore’s most premier Age Group Competition event of the whole calendar year.

CSC invites proposals from experienced operators with a proven track record in managing successful badminton programs. The selected operator will work closely with CSC to drive the long-term growth of the academy and ensure that it aligns with CSC’s vision of sporting excellence.
