IMPORTANT INFORMATION

- 1. Minimum Commitment Period: 3 Months
- 2. **Commitment Requirement**: Members are required to commit to the pickleball section for a minimum of 3 months. After this period, they may be eligible to downgrade from Tier 2 to Tier 1 or withdraw from the section.
- 3. **Early Withdrawal**: Members who withdraw before completing the 3-month commitment must pay the section fees for the remaining month(s).
- 4. **Tier Upgrade**: Members can upgrade from Tier 1 to Tier 2 at any time during the month. Upgrading will result in a billing adjustment to reflect the higher section fees. Official registration for the upgrade must be submitted to the Sports Desk or Sports Email.
- 5. **Withdrawal Notice Before 15th**: If the withdrawal notice is received by the Club on or before the 15th day of the month, it will be processed within that month, and charges for the activity will cease in the following month.

- 6. **Withdrawal Notice After 15th**: If the withdrawal notice is received by the Club after the 15th day of the month, it will be processed in the following month. Charges for the activity will be debited accordingly in the following month and will cease thereafter.
- Authorization for Debits: I hereby authorize the Club to debit \$5.45 / \$10.90 (inclusive of 9% GST) per month from my account, even if I do not participate regularly in the Pickleball Section.
