Terms & Conditions

- 1. Minimum 3 trainees and maximum 4 trainees per group.
- 2. There shall be no refund or pro-rated fee for any withdrawal when the programme has commenced.
- 3. Completed registration form must be submitted to CSC Front Desk/Sport Reception with relevant payment or shall be debited from member's CSC account prior to the commencement of the programme.
- 4. Completed withdrawal form must be submitted to CSC Front Desk/Sport Reception two weeks prior to the commencement of next term if the trainee does not wish to continue after the end of 8 sessions programme. Otherwise, it shall be deemed as trainees will be continuing the next term.
- 5. Registration form shall be processed and accepted by CSC & Ultimate Squasher on a first come first served basis.
- 6. Training shall continue as scheduled on Public Holiday unless otherwise agreed and communicated.
- 7. CSC & Ultimate Squasher reserves the right to cancel any training session at any time and shall use its best endeavours to inform trainees and/or parents of such cancellation in advance but shall not be liable if no advance notice is given. Where CSC or Ultimate Squasher have cancelled a training session, replacement training session may be arranged on the next available date falling within fourteen (14) days of the cancelled training session subject to availability.
- 8. There shall be no refund or pro-rated of training fees arising from any cancellation.
- 9. All trainees and/or parents shall comply with the terms and conditions governing the use of the facilities at all times.
- 10. CSC reserves the right to impose a reinstatement fee for any damage caused to the Club or its property by any Trainee. CSC shall determine the cost of the damage.

Non-CSC Member

- 1. Trainees can only access the Club during their training period and are required to leave the Club immediately after training.
- 2. Any facilities other than the Squash Courts and rest room is out of bounds to the Trainees.
- 3. Non-CSC members trainees are required to make payment two weeks before commencement of the next term if they wish to continue. Failure to do so, their slots will be given to the next trainees on the waitlist list.

* IMPORTANT - PLEASE NOTE:

- 1. CSC member Trainees who fail to settle their CSC member's account within 90 days of the due date for payment shall be deemed to have withdrawn from the Academy.
- 2. Where a CSC member Trainee ceases to be a CSC member but wishes to continue participation in the Training Course, the Trainee shall re-register for the Training Course as a non-CSC member Trainee by completing the registration form for non-CSC member and the Monthly Training Course Fees structure for a non-CSC member shall apply.
