A note to Parent

1. Please submit this application together with the following documents and payment on or before 20th of the month for approval at Membership Relations Committee and Management Committee Meetings.
 - a) recent photograph of applicant
 - b) copy of applicant's birth certificate
 - c) copy of applicant's NRIC/passport
 - d) registration fee \$436 per child
 - e) an administrative fee of \$109 per child, where applicable (Please refer to item 2b below for details).
- 2a. All children of Principal, Nominee or Term Member shall be registered with the Club as Junior/Junior Term Members within six (6) months of each child attaining the age of twelve (12).
- 2b. If a child of a Principal, Nominee or Term Member is not registered with the Club in accordance with the Constitution Article 5.1(g)(vi), that Member will be required to register his/her child as a Junior/Junior Term Member and pay an administrative fee of \$109. Failure to do either may result in disciplinary proceedings against that Member.
- 2c. As long as the Principal, Nominee or Term Membership is not terminated, that individual shall not be permitted to de-register his/her child's Junior/Junior Term Memberships respectively, except in the event of death or where the member loses custody of the child.
3. The subscription fee for Junior/Junior Term Membership shall be billed in advance to your account on a monthly basis.
