1. Please submit this application together with the following documents and payment on or before 20th of the month for approval at Membership Relations Committee and Management Committee Meetings.
 - a) recent photograph of spouse
 - b) copy of marriage certificate
 - c) copy of spouse's NRIC
 - d) an administrative fee of \$109
2.
 - a) All married persons who become Principal Members, Nominees or Term Members on or after **28 April 2013** are required to register their spouse as Spouse Members. All single persons who become Principal Members or Term Members on or after **28 April 2013**, and are subsequently married are also required to register their spouse as Spouse Members.
 - b) If the Spouse of a Principal, Nominee or Term Member is not registered with the Club in accordance with Article 5.1(f)(i) of the Club's Constitution, that Member will be required to register his/her spouse as a Spouse Member and pay an administrative fee of \$109. Failure to do either may result in disciplinary proceedings against the member.
 - c) With effect from **28 April 2013**, as long as the Principal, Nominee or Term Membership is not terminated, that individual shall not be permitted to de-register his/her spouse, except in the event of divorce or death.
3. For registration of new spouse membership, the Principal Member has to withdraw the membership of the previous registered spouse. Relevant documents must be submitted and the previous spouse's membership card can be returned to the Club. (Note: A penalty charge of \$10.90 will be imposed if spouse membership card is not returned)
4. If any person is de-registered as a Spouse Member prior **28 April 2013**, an administrative fee of \$109 is payable for a fresh application to be Spouse Member.
5. The subscription fee of \$10.90 for Spouse Member or Spouse Term Member shall be billed in advance monthly.
6. For Life Member without a credit account, payment of \$200 credit deposit is required for credit account.
7. Any child, of a Principal, Nominee or Term Member, under the age of 12 years must be registered with the Club as child dependent and such a child may use the Club's facilities without payment of a guest fee. A copy of your child's birth certificate is required for registration.
8. All fees include 9% GST.
