Training Information

- Venue: Chinese Swimming Club Table Tennis Room, Sports Complex Level 3, 21/34 Amber Road
 - Age Group: 4 – 14 years old
 - Training will continue as scheduled on Public Holidays except Chinese New Year and unless otherwise stated.
 - CSC and / or the Academy reserve the right to cancel any training session at any time. CSC and / or the Academy shall use its best endeavours to inform trainees of any such cancellation in advance but shall not be liable if no advance notice is given. Where CSC and / or the Academy have cancelled a training session, Trainees may replace that the said session on the next available date falling within fourteen (14) days of the date of the cancelled training session subject to availability.
 - There shall be no refund or pro-ration of Training Fees arising from any cancellation.
- Training Fee Pro-Rations: Trainees who are unable to attend due to illness or injury are required to produce a medical certificate to process the refund. There shall be no refund or pro-ration of training fees arising from any absence for non medical-related reasons. Parents would need to inform and seek approval from the club at least one month in advance for any suspension of lessons due to non-medical reasons (E.g travels). Notice given shorter than one month will not be approved and fees will be charged for the missed lesson.
- There will be no make-up class granted if your child is unable to attend training due to any reason except for lesson missed due to school with supporting document furnished to us.

Withdrawal Procedure

- A duly completed official withdrawal form must reach CSC on or before the 15th of the current month for cessation of training to be effective the following month. Training will only cease the month following the next month if CSC receives the withdrawal form after the 15th of the month.

* IMPORTANT - PLEASE NOTE:

- Non-CSC member Trainees who fail to settle payment by the stipulated date shall be deemed to have withdrawn from the Academy.
- CSC member Trainees who fail to settle their CSC member's account within 90 days of the due date for payment shall be deemed to have withdrawn from the Academy.

- Where a CSC member Trainee ceases to be a CSC member but wishes to continue participation in the Training Course, the Trainee shall re-register for the Training Course as a non-CSC member Trainee by completing the registration form for non-CSC member and the Monthly Training Course Fees structure for a non-CSC member shall apply. The enrolment fees for the re-registration shall be waived if the Trainee re-registers as a non-CSC member Trainee within 14 days from the cessation of his CSC membership.

Rules & Regulations

General

- The welcome pack consists of 1 Academy t-shirt & 1 pair of shorts.
- CSC and / or the Academy reserves the right to refuse any Trainee access to any training or other Academy programme where that Trainee is not wearing Academy T-shirt or improperly attired.
- No outside food may be brought into the Club.
- All Trainees and caregivers shall comply with the terms and conditions governing the use of CSC's facilities at all times.
- CSC and their appointed staff and officials reserve the right not to admit any person who has been previously ejected from its premise.
- CSC and their appointed staff and officials reserve the right to eject any Trainee or caregiver who behaves in a disorderly manner or who is nuisance or a threat in its premises.
- CSC reserves the right to impose a reinstatement fee for any damage caused to the Club or its property by any Trainee. CSC shall determine the cost of the damage.
- Photography/Videography: Photographs and videos may be taken for use in the CSC's archival and publicity material.

Non-CSC Member

- Trainees can only access the Club during their training period and are required to leave the Club immediately after training.
- Any facilities other than the Table Tennis Room and restroom is out of bounds to the Trainees.
- CSC/LJW shall have the right to forfeit and/or set off the deposit against any outstanding Training fees or other fees and any expenses incurred or to be incurred by CSC and/or LJW to rectify any damage caused by the non-CSC member Trainee, or in the event that the non-CSC member Trainee is expelled for whatever reason.
- Trainees shall be withdrawn from the Academy if they or their caregiver breach any of the above terms and conditions. Their deposit shall be forfeited.

Indemnity

It is the responsibility of all parents to inform the coaches if the children are feeling unwell or sick or have just recovered from any sign of injuries or sickness.
