## Terms & Conditions

### Introduction

These Terms & Conditions (“T&Cs”) govern the “March Holiday Special” Membership Promotion (“Promotion”) 2026. By applying for new Ordinary/ Associate membership and/or participating in this Promotion, each applicant and/or successful member and/or existing member (“Participant”) agrees to be bound by these T&Cs, as well as the Club’s Constitution, Bye-Laws, membership policies, house rules, and all other prevailing terms, conditions, procedures, and requirements applicable to membership and the use of Club facilities and privileges (collectively, “Club Rules”).

### Promotional Mechanics

- a. \$600 Spending Credits for all New Members applying for Ordinary/ Associate Membership
- b. \$600 Spending Credits for existing members who has successfully referred a new member to apply for Ordinary/ Associate Membership

## 1. Promotion Period, Application & Approval

### 1.1 Promotion Window

The Promotion is available from **1 March 2026 to 25 March 2026**, both dates inclusive (“Promotion Period”).

For avoidance of doubt, the Promotion Period is based on the Club’s official system records and/or the Club’s determination of when an application and payment are received, processed, and successfully matched. The Promotion Period is to be strictly enforced and the Club reserves the right to change it without prior notice.

### 1.2 Cut-Off

The last date for application submission is **25 March 2026** (“Closing Date”). Applications submitted after the Closing Date are not eligible.

### 1.3 Approval Prerequisite

Receipt of Promotion benefits is conditional upon successful membership approval, full settlement of all payable fees at sign-up and submission of signed referral forms, in accordance with Club Rules. Submission by the Closing Date does not guarantee approval.

### 1.4 Approval Timing

Applications submitted by the Closing Date but approved thereafter may still qualify at the Club’s discretion, provided the application was complete and duly lodged by the Closing Date. Membership will only take effectiveness on the 1<sup>st</sup> Day of the following month of submission date.

### 1.5 Club Discretion

The Club may accept or reject any application without assigning reasons and may request additional information to determine eligibility.

### 2. Eligibility & Scope

#### 2.1 Who May Participate

Unless a specific membership circular states otherwise, the Promotion only applies to new Ordinary/ Associate membership sign-ups approved within the Promotion window.

Existing Members of the club are only able to participate as “Referring Members”

**This promotion is exclusively applicable to buyers matched by the Club through the official Membership Seller List that is unpublished and maintained solely by the Club.**

#### 2.2 Exclusion

Renewals, reinstatements, upgrades/downgrades, and conversions from existing categories are excluded. Buyers who are sourcing their own sellers (direct-sellers and Club Membership Agents) will not be eligible for this promotion.

#### 2.3 Limits of Promotion

Promotion benefits are limited to one (1) set per approved new principal membership. Duplicate claims are strictly not permitted.

Existing members may refer as many New Members as they want and will be provided one (1) set for each successful applications.

#### 2.4 Good Standing

Benefits are issued only to Members in good standing (no outstanding arrears, no suspensions). The Club may withhold or cancel benefits if the Member’s account becomes delinquent or subject to disciplinary action.

#### 2.5 Non - Assignability

Eligibility is personal to the approved principal Member and is not transferable to another individual or membership.

### 3. Promotion Benefits (the “Items”)

Subject to these Terms, each eligible, approved membership receives:

#### a) Chinese Swimming Club Spending Credits Worth S\$600 for New Members

A non-cash Club credit usable for Club expenditures, including (non-exhaustive) F&B, facilities and classes. Express exclusion: Spending Credits cannot be used to pay monthly membership subscription fees.

#### b) Chinese Swimming Club Spending Credits Worth S\$600 for Existing Members

A non-cash Club credit usable for Club expenditures, including (non-exhaustive) F&B, facilities and classes. Express exclusion: Spending Credits cannot be used to pay monthly membership subscription fees.

**Not combinable: This Promotion (and its Items) strictly cannot be used in conjunction with any other ongoing Club promotions, discounts, coupons, package rates or privileges.**



## Terms and Conditions

### 4. Benefits Terms, Issuance, Activation & Mode of Use

#### 4.1 Issuance timeline

Upon approval and effectiveness of the membership, the Club will:

- a) Credit the Spending Credits to the Member's account.

#### 4.2 Activation

Chinese Swimming Club Spending Credits will be activated and automatically deducted/ allocated for monthly expenses. Members are to keep track of their own Spending Credits balances.

#### 4.3 Spending Credits (S\$600) — Use & Limitations

- a) Spending Credits are a non-cash, non-transferable credit maintained in the Member's account.
- b) The credits may be applied to Club expenditures including (non-exhaustive) F&B, facilities (e.g., court bookings), and classes/programmes that are billable to the Member's account under Club Rules.
- c) Explicit Exclusion

Spending Credits cannot be used to pay monthly membership subscription fees or the F&B levy. They also cannot be used to offset late payment fees, administrative fees, or any other related charges imposed on the membership. Spending credits cannot be used at tenanted outlets, Fu Lin Men Cantonese Dining and FIL Spa.

- d) Refunds/Voids

If a charge paid with Spending Credits are voided or refunded, the refundable portion (if any) is returned as Spending Credits only, no cash refunds.

- e) Validity Period

Unless otherwise notified in writing, Spending Credits are valid for twelve (12) months from the date of membership effectiveness. Unused balances expire at the end of validity.

- f) Account Standing

Spending Credits may be temporarily inaccessible if the Member's account is in arrears or suspended. Upon regularisation, access may resume within standard processing times.

- g) Forfeiture on Cessation

Any unused Spending Credits will be forfeited upon membership resignation, termination, or expiry (if not otherwise transferred under an approved policy).



## Terms and Conditions

### 5. Non-Combinability, Fraud and Misuse

#### 5.1 No Stacking with Other Offers

No stacking with other offers. The Promotion is not valid in conjunction with any other ongoing Club Promotions, such as the current Members Get Members promotion, existing discounts, or special packages.

#### 5.2 No Multiple Redemptions

Each approved membership may receive and redeem one set of Items only. Attempts to duplicate, split, or reissue benefits are strictly prohibited and may arise disciplinary actions.

#### 5.3 Inconsistencies

Where a conflict arises between these Terms and any marketing creative, these Terms prevail.

#### 5.4 Where a membership application is potentially eligible for multiple Club promotions and a conflict arises, the **membership applicant/purchaser** shall have the right, at their sole and absolute discretion, to select **one (1)** eligible promotion to be applied. There will be zero (0) changes allowed once the decision is made.

### 6. Data Protection

#### 6.1 PDPA Consent

By participating, the applicant consents to the Club's collection, use, and disclosure of personal data for membership administration, Promotion fulfilment, communication, billing, and related Club purposes, in accordance with the Club's Personal Data Protection policy.

### 7. Liability, Risk & Force Majeure

#### 7.1 Use at Own Risk

The Member, dependants, and guests use Club facilities and merchant services at their own risk and must comply with all safety instructions.

#### 7.2 Club Limitation

To the fullest extent permitted by law, the Club is not liable for indirect, incidental, or consequential losses arising from the Promotion or use of the Items.

#### 7.3 Force Majeure

The Club is not liable for delays or non-performance caused by events beyond its reasonable control (e.g., government restrictions, pandemics, acts of God). Temporary closures or restrictions do not entitle Members to cash compensation.



## Terms and Conditions

### 8. Amendments & Interpretation

#### 8.1 Right To Amend

The Club reserves the right to amend, suspend, or terminate the Promotion and/or these Terms at any time without prior notice. Updates take effect when published on official Club channels.

#### 8.2 Final decision

The Management Committee's interpretation and decisions on all matters relating to the Promotion are final and binding.
