



SG61 Membership Promotion 2026 Terms and Conditions

Introduction

These Terms & Conditions ("T&Cs") govern the SG61 Membership Promotion 2026 ("Promotion"). By applying for a new Ordinary or Associate Membership and/or participating in this Promotion, each applicant, successful member and/or existing member agrees to be bound by these T&Cs, as well as the Club's Constitution, Bye-Laws, membership policies, house rules and all other prevailing terms, conditions, procedures and requirements governing membership and the use of the Club's facilities and privileges (collectively, the "Club Rules").

Promotional Mechanics

- **\$1,000 Spending Credits for New Members applying for Ordinary/ Associate Membership**
- **Vouchers & Gifts Worth Up to \$1,000 for New Members applying for Ordinary/ Associate Membership**

1. Promotion Period, Application & Approval

1.1 Promotion Period

The Promotion is valid from 1 August 2026 to 25 August 2026, both dates inclusive (the "Promotion Period").

For the avoidance of doubt, the Promotion Period shall be determined solely by the Club's official records, including the date and time the membership application and all required payments are received, processed and successfully matched by the Club.

Applications and/or payments received, processed or matched outside the Promotion Period will not be eligible for this Promotion. The Club reserves the right to amend, extend, shorten, suspend, or terminate the Promotion Period at any time without prior notice.

1.2 Application Closing Date

The last date for submission of membership applications is 25 August 2026 (the "Closing Date"). Membership applications received after the Closing Date will not be eligible for this Promotion, regardless of the reason for the delay.

1.3 Approval Prerequisite

Eligibility for the Promotion and receipt of the Promotion benefits are conditional upon:

- the successful approval of the membership application by the Club;
- full payment of all applicable fees payable upon sign-up; and
- where applicable, the submission of duly completed and signed referral form(s), all in accordance with the Club Rules.

Submission of a membership application by the Closing Date does not guarantee approval or entitlement to the Promotion benefits. The Club reserves the sole and absolute discretion to approve or reject any membership application in accordance with its prevailing policies and procedures.

1.4 Approval Timing

Membership applications submitted by the Closing Date but approved after the Closing Date may still qualify for the Promotion, provided that the application was complete, duly submitted, and all applicable fees were paid by the Closing Date.

For the avoidance of doubt, approval of a membership application is subject to the Club's review and approval process. Membership shall take effect on the first day of the month following the month in which the membership application is submitted, subject to approval by the Club.

1.5 Club's Discretion

The Club reserves the right, at its sole and absolute discretion, to approve or reject any membership application without assigning any reason. The Club may also require the applicant to provide such additional information or supporting documents as it deems necessary to determine the applicant's eligibility for membership and/or the Promotion.

2. Eligibility & Scope

2.1 Who May Participate

Unless otherwise stated in a specific membership circular or promotional material issued by the Club, this Promotion is open only to applicants for new Ordinary or Associate Memberships whose applications are approved in accordance with these T&Cs, the Club's Constitution, Bye-Laws, and all other applicable Club Rules.

This Promotion is applicable only to applicants/buyers who are successfully matched by the Club through the Club's official Membership Seller List. The Membership Seller List is maintained solely by the Club and is not publicly available. The Club reserves the right to determine eligibility for participation in this Promotion based on its official records and verification process.

Existing Members of the Club are not eligible to participate as applicants under this Promotion but may participate solely as Referring Members under the Club's prevailing Member Referral Scheme, where applicable and subject to the applicable terms and conditions of the scheme.

2.2 Exclusion

The Promotion does not apply to membership renewals, reinstatements, upgrades, downgrades, or conversions from any existing membership category.

Buyers who source their own sellers, including through direct seller arrangements or Club Membership Agents, are not eligible for this Promotion. Only buyers successfully matched by the Club through the Club's official Membership Seller List are eligible, unless otherwise determined by the Club.

2.3 Limits of Promotion

Each approved new Principal Membership is entitled to only one (1) set of Promotion benefits. Duplicate, multiple or repeated claims for the same membership application are strictly prohibited.

There is no limit to the number of new members an existing member may successfully refer during the Promotion Period. The Referring Member will be entitled to one (1) set of applicable referral benefits for each successful new membership application, subject to these T&Cs and the Club Rules.

2.4 Good Standing

Promotion benefits will only be issued to Members whose membership accounts are in good standing, with no outstanding arrears, suspensions, or other restrictions imposed by the Club. The Club reserves the right to withhold, suspend, withdraw or cancel any Promotion benefits if a Member's account becomes overdue, suspended or is subject to disciplinary action, or if the Member is otherwise found to be in breach of these T&Cs or the Club Rules.

2.5 Non-Assignability

Eligibility for the Promotion and the associated Promotion benefits is personal to the approved Principal Member and may not be assigned, transferred, sold, exchanged or otherwise made available to any other individual or membership.

3. Promotion Benefits

Subject to these T&Cs, each eligible, approved membership receives:

3.1 Chinese Swimming Club Spending Credits Worth \$1,000 for New Members

Eligible New Members will receive Chinese Swimming Club Spending Credits worth \$1,000 ("Spending Credits"). Spending Credits are non-cash Club credits that may be used for eligible Club expenditures, including but not limited to food and beverage purchases, the use of Club facilities and Club programmes or classes. For the avoidance of doubt, Spending Credits cannot be used to pay monthly membership subscription fees or any other fees, charges or expenses expressly excluded by the Club from time to time. Spending Credits are subject to the Club's prevailing Spending Credits Terms & Conditions, as amended from time to time.

3.2 Vouchers & Gifts Worth Up to \$1,000 for New Members

Eligible New Members will receive vouchers and gifts with a total value of up to \$1,000, sponsored by the Club's participating partners.

All vouchers and gifts are subject to availability and the respective participating partners' terms and conditions, including any validity period, redemption requirements, usage restrictions, exclusions, and other applicable conditions. The Club is not responsible for the products, services, or fulfilment provided by the participating partners and reserves the right to substitute any voucher or gift with another of similar value without prior notice.

Non-Combination with Other Promotions: This Promotion and its associated Promotion benefits may not be used in conjunction with any other Club promotion, offer, discount, voucher, coupon, package, rebate, privilege, or incentive, unless otherwise expressly approved by the Club in writing.

4. Benefits Terms, Issuance, Activation & Mode of Use

4.1 Issuance Timeline

Upon approval of the membership application and once the membership becomes effective, the Club will credit the Spending Credits to the Member's account.

4.2 Activation

Chinese Swimming Club Spending Credits will be activated upon issuance and will be automatically applied to eligible monthly expenses. Members are responsible for monitoring the balance of their Spending Credits.

4.3 Spending Credits (\$1,000) Uses & Limitations

- a) Spending Credits are a non-cash and non-transferable credit maintained in the Member's account.
- b) The Spending Credits may be used for eligible Club expenditures charged to the Member's account in accordance with the Club Rules including but not limited to food and beverage purchases, Club facilities (e.g. court bookings) and Club programmes or classes.

- c) **Explicit Exclusions**

Spending Credits cannot be used to pay monthly membership subscription fees, the Food & Beverage Levy, late payment fees, administrative fees or any other fees, charges, penalties, or amounts imposed on the membership account. Spending Credits are also not valid for use at tenanted outlets, including Fu Lin Men Cantonese Dining and FIL Spa, or at any other outlets or services as may be designated by the Club from time to time.

- d) **Refunds/Voids**

Where a transaction paid using Spending Credits is subsequently voided, cancelled, or refunded, any refundable amount (if applicable) will be credited back to the Member's Spending Credits balance only. No cash refunds, cash equivalents, or alternative forms of compensation will be provided for any amount refunded from transactions paid using Spending Credits.

- e) **Validity Period**

Unless otherwise notified by the Club in writing, Spending Credits are valid for a period of twelve (12) months from the membership effective date. Any unused Spending Credits remaining after the expiry of the validity period will automatically lapse and be forfeited. No extension, replacement, refund, or compensation will be provided for expired Spending Credits.

- f) **Account Standing**

Spending Credits may be temporarily suspended, withheld, or inaccessible if the Member's account is in arrears, suspended, or otherwise not in good standing.

Upon full settlement of outstanding amounts and/or regularisation of the Member's account, access to the Spending Credits may be restored, subject to the Club's standard processing timelines and prevailing policies.

- g) **Forfeiture Upon Cessation of Membership**

Any unused Spending Credits will be automatically forfeited upon the resignation, termination or expiry of the Member's membership, unless otherwise permitted under an approved Club policy or expressly approved by the Club in writing.

No cash refund, replacement, transfer, or compensation will be provided for any forfeited Spending Credits.

5. Non-Combinability, Fraud and Misuse

5.1 No Stacking with Other Offers

This Promotion and its associated benefits cannot be used in conjunction with any other ongoing Club promotions, discounts, offers, coupons, package rates, privileges, or incentives, unless otherwise expressly approved by the Club in writing. Existing discounts, special packages, or other promotional benefits shall not be applicable in addition to this Promotion.

5.2 No Multiple Redemptions

Each approved membership is entitled to receive and redeem one (1) set of Promotion benefits only. Any attempt to duplicate, split, transfer, reproduce, or reissue any Promotion benefits is strictly prohibited and may result in the withdrawal of the benefits and/or disciplinary action in accordance with the Club Rules.

5.3 Inconsistencies

In the event of any inconsistency, discrepancy, or conflict between these Terms & Conditions and any marketing materials, promotional creatives, advertisements, or communications relating to this Promotion, these Terms & Conditions shall prevail.

5.4 Selection of Promotion Benefits

Where a membership application is eligible for more than one Club promotion and a conflict arises between the applicable promotions, the applicant/purchaser may select one (1) eligible promotion to be applied to the membership application.

The selection must be made at the time of application or within the timeframe specified by the Club. Once the promotion has been selected and applied, the decision shall be final and no changes, substitutions, or requests to switch to another promotion will be permitted.

6. Data Protection

6.1 PDPA Consent

By participating in this Promotion, the applicant consents to the Club's collection, use, and disclosure of their personal data for purposes including, but not limited to, membership administration, Promotion fulfilment, communications, billing, and other related Club purposes.

Such collection, use, and disclosure of personal data shall be carried out in accordance with the Club's prevailing Personal Data Protection Policy and applicable data protection laws and regulations.

7. Liability, Risk & Force Majeure

7.1 Use at Own Risk

Members, their dependants and guests use the Club's facilities and merchant services at their own risk and are required to comply with all applicable safety instructions, guidelines and rules issued by the Club from time to time.

7.2 Limitation of Liability

To the fullest extent permitted by law, the Club shall not be liable for any indirect, incidental, special or consequential loss, damage, cost or expense arising out of or in connection with the Promotion, the provision, redemption, or use of any Promotion benefits or Items.

7.3 Force Majeure

The Club shall not be liable for any delay, failure, suspension, or inability to perform its obligations under these Terms & Conditions where such delay, failure, suspension, or inability arises from events beyond the Club's reasonable control, including but not limited to government restrictions, pandemics, natural disasters, acts of God, or other unforeseen circumstances.

Temporary closure of Club facilities, restrictions on access, or changes to Club operations arising from such events shall not entitle Members to any cash compensation, refund, replacement benefits, or other form of compensation.

8. Amendments & Interpretation

8.1 Right To Amend

The Club reserves the right, at its sole and absolute discretion, to amend, suspend, withdraw, or terminate the Promotion and/or these Terms & Conditions at any time without prior notice.

Any amendments, updates, or changes shall take effect upon publication through the Club's official communication channels or such other channels as determined by the Club.

8.2 Final decision

The Management Committee's interpretation of these Terms & Conditions and its decisions on all matters relating to the Promotion shall be final, conclusive and binding on all applicants and Members.
